The 12-lead reports can be reviewed and confirmed from any authorized PC client on the hospital network, as well as from the Ultraview SL patient monitors utilizing Spacelabs proprietary WinDNA(R) technology.

The Sentinel brings together data collected from a variety of Diagnostic Cardiology products positioning Spacelabs within the market as a fully integrated provider of Information Management Solutions. Additionally, with the launch of Sentinel we have the ability to leverage our existing patient monitoring customers in the United States to help drive sales of our Diagnostic Cardiology products which to date have primarily been sold within the European market."
